Note to the reader

The latest available consolidated trade data at EU level cover market developments up to March 2025. Monthly figures are compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.


The trade figures are expressed in values, except when specifically mentioned. Price variations are based on a unit value that is the average price of products traded in the period concerned (trade value at the border divided by the quantity registered).

HIGHLIGHTS: EU trade remained strong in the first quarter 2025, but surplus fell due to high import prices

EU exports reached EUR 21.1 billion in March 2025, an increase of 8 % on the previous month and 5 % higher than in March 2024. Over the first quarter of the year, EU exports reached EUR 59.7 billion, this is 3 % higher than in the same period in 2024. Prices for exports of cocoa based products remained high, while exports of cereals declined.

EU imports increased by 11 % month-on-month in March, reaching EUR 16.9 billion, a 24 % increase on March 2024. Between January and March, cumulative imports reached EUR 48.1 billion, up 20 % on the first quarter of 2024. This is explained by high import prices, in particular for cocoa and coffee, as well as fruit and nuts.

The EU agri-food trade surplus remained stable in March compared to the previous month and reached EUR 4.3 billion. Over the first quarter of the year, the EU surplus reached EUR 11.6 billion. This is a reduction of EUR 6.1 billion compared to the first quarter 2024, primarily due to increases in prices of EU imports.





EU AGRI-FOOD EXPORTS

UK, US AND SWITZERLAND WERE THE TOP EU EXPORT DESTINATIONS IN THE BEGINNING OF 2025

EU agri-food exports reached EUR 21.1 billion in March 2025, an 8 % increase on the previous month and 5 % higher than in March 2024. In the first quarter of the year, EU exports reached EUR 59.7 billion, an increase of 3 % (+ EUR 1.9 billion) compared to the same period in 2024.

The **UK** remained the first destination of EU exports, with EUR 13.5 billion in the first quarter of 2025 (23 % of EU agri-food exports). This is an increase of EUR 583 million (+5 %) compared to the same period in 2024, mainly due to increased prices of cocoa based products.

The **US** remained the second destination of EU exports, with EUR 7.9 billion in the first quarter of the year (13 % of EU exports). This is an increase of EUR 752 million (+11 %) compared to 2024, partly explained by an increase in the value of cocoa based products, as well as wine and spirits.

Switzerland was the third destination of EU exports between January and March, with EU exports reaching EUR 3.4 billion (6 % of EU exports). Exports grew by EUR 373 million (+12 %) compared to 2024 (mainly due to the high prices of cocoa products).

On the other hand, **China** fell behind Switzerland and was the fourth destination of EU exports in the first quarter, with exports reaching EUR 3.1 billion (5% of EU exports). This is explained by a reduction in EU exports of EUR 437 million (-12%)

in the first quarter compared to 2024, due to a strong reduction in the volume of cereals exports (-2.3 million t, -99 %).

EXPORTS OF CEREALS HAVE DECLINED COMPARED TO 2024

Exports in the **coffee, tea, cocoa and spices** category had the largest increase in value, with a rise of EUR 1.1 billion (+51 %) in the first quarter of 2025 compared to 2024. This was mainly driven by a more than twofold price increase for cocoa paste, butter and powder exports.


Exports of **confectionery and chocolate** also increased by EUR 539 million (+21 %), mainly due to the high prices of chocolate exports.

Exports of **dairy products** increased by EUR 327 million (+7 %), primarily due to increases in prices.

By contrast, EU **cereals** exports decreased by EUR 1 billion (-27 %) in the first quarter of 2025 compared to 2024. This is mainly explained by reductions in exported volumes, for both wheat (-40 %, -4.1 million t) and maize (-39 %, -0.5 million t), while prices increased.

Exports of **olives and olive oil** decreased by EUR 173 million (-9 %) compared to 2024, as prices have eased up after their peak in 2024, but volumes exported increased by 16 %.

Exports of **preparations of fruit, nuts and vegetables** decreased by EUR 142 million (-4 %), due to reduced volumes.



EU AGRI-FOOD IMPORTS

BRAZIL, US AND UK TOPPED EU IMPORT SOURCES IN FIRST QUARTER

The value of EU agri-food imports reached EUR 16.9 billion in March 2025. This is 11% higher than the previous month and 24% higher than in March 2024. Over the first quarter of the year, EU imports reached EUR 48.1 billion. This is an increase of EUR 7.9 billion (+20%) compared to 2024, mainly explained by high prices for several EU imports, particularly cocoa and coffee.

Brazil remained the top origin of EU imports in the first quarter, as they reached EUR 4 billion (8 % of EU imports), with an increase of EUR 359 million (+10%) compared to the same period in 2024, mainly due to high coffee prices.

The **US** followed closely behind as the second source of EU imports in the first quarter, just below EUR 4 billion. Imports from the US increased by EUR 684 million (+21 %), mainly due to a significant increase maize imports that reached 1.9 million t in the first quarter.

The **UK** was the third origin of EU imports, with EUR 3.8 billion in the first quarter, an increase of EUR 145 million (+4%) compared to the same period in 2024.

Among other significant developments, imports from **Côte d'Ivoire** saw the largest increase in value compared to 2024 (+ EUR 1.2 billion, +84 %) and reached EUR 2.6 billion, mainly due to high cocoa prices. Imports from **China** increased by EUR 732 million (+35 %) and reached EUR 2.8 billion, due to increases across most product categories, notably non-edible products (including fatty acids and waxes).

Imports from **Canada** increased by EUR 532 million (+88 %), mainly due to large increases for cereals and oilseeds. Imports from **Australia** increased by EUR 508 million (+149 %), mainly due to a strong increase in rapeseed imports.

By contrast, imports from **Russia** decreased by 78 % (- EUR 336 million) in the first quarter compared to 2024, largely due to a sharp reduction in imports of oilseeds and cereals.

Imports from **Ukraine** decreased by EUR 128 million (-4%), reaching EUR 3.4 billion and falling back to the fourth source of EU imports. This was mainly due to lower imports of cereals (-1.4 million t, notably maize and wheat) and oilseeds (rapeseed).

HIGH PRICES KEEP DRIVING EU IMPORTS

Imports of **coffee, tea, cocoa and spices** increased by EUR 4.2 billion (+69 %) in the first quarter of 2025 compared to 2024. This is mainly explained by higher import prices: cocoa prices doubled, and coffee prices rose by 65 %. Imports of **fruit and nuts** also grew by EUR 1.1 billion (+18 %), mainly due to higher prices (+15 %). Imports of **non-edible products** increased by EUR 457 million (+21 %), mainly due to higher prices. Imports of **cereals** increased by EUR 434 million (+18 %), mainly due to increased volumes of maize (+28 %), while those of wheat declined.

By contrast, imports of **sugar and isoglucose** decreased by EUR 197 million (-39 %), mainly due to reduced volumes. Imports of **olives and olive oil** decreased by EUR 167 million (-32 %) due to both lower import prices and volumes.


